The mailing address and street address of the principal office of the Corporation shall be 7101 Eagle Terrace, West Palm Beach, Florida 33412.


**ARTICLE III - INITIAL REGISTERED OFFICE AND REGISTERED AGENT**

The aggregate number of shares which this Corporation shall have authority to issue is Ten Thousand (10,000) shares of common voting stock.


