The undersigned incorporator, for the purpose of forming a Professional Association under the Florida Professional Service Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE 1 - NAME

The name of this Professional Association is: VALLYE ADAMS, P.A.

ARTICLE II - PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation shall be: 7070 Middlebury Drive, Boynton Beach, FL 33436

ARTICLE III - PURPOSE

The general nature and purposes of business to be transacted, promoted and carried on by the corporation are as follows:

- To engage in every aspect in the practice of real estate sales, and all its fields of specializations.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares that this corporation is authorized to have outstanding at any one time is 500 shares of Common Stock, for a nominal or par value of \$1.00 per share.

ARTICLE V - CORPORATE ELECTION

The corporation elects to be governed by the provisions of the Florida Professional Service Comparation and Limited Liability Company Act, §621, Florida Statutes.

ARTICLE VI - DURATION

The Corporation shall have perpetual existence.

ARTICLE VII - SEVERANCE AND TERMINATION

Every stockholder, upon sale for cash of any new stock in this corporation of the same kind, class or series as that which he/she already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at a price at which it is offered to others.
