The undersigned hereby presents these Articles for the formation of a corporation under the laws of the State of Florida.

**ARTICLE I
CORPORATE NAME**

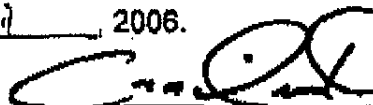
CUMULATIVE VOTING FOR DIRECTORS
