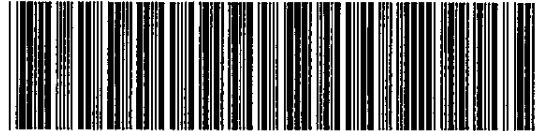



THE UNDERSIGNED incorporator hereby forms a corporation under Chapter 607 of the laws of the State of Florida.

This Corporation is to exist perpetually.


ARTICLE V - DIRECTORS
