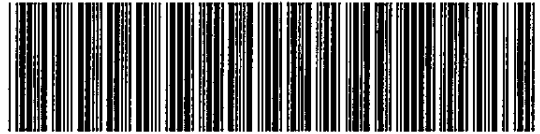

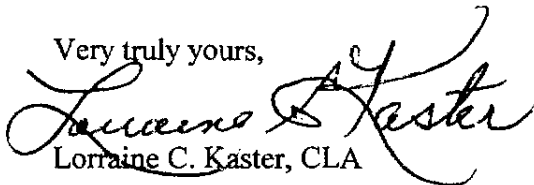

ARTICLE I - Name

The name of the corporation shall be: **A & D BUSINESSES, INC.**

ARTICLE II - Duration

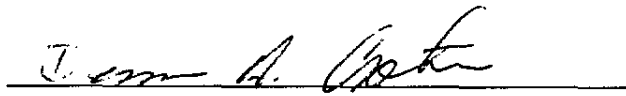

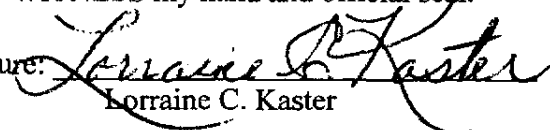
