

AMENDMENT



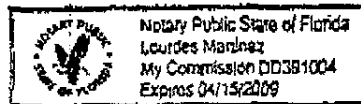


