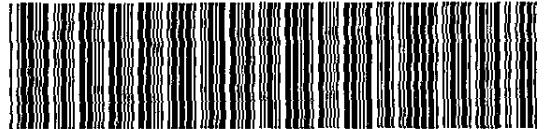

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as the incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation is: Studio 15, Inc.

The existence of the Corporation shall begin on: May 1, 2005.

ARTICLE III
