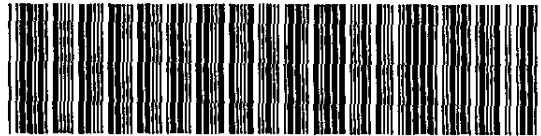



The undersigned hereby forms a Corporation under the following Charter of Articles of Incorporation:

ARTICLE I

The name of this Corporation shall be Medical Patents 21 Corp. The address of this corporation is 9776 S. Military Trail, Boynton Beach, Florida 33436.

ARTICLE II
