ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of LIGHTNING STRIKE, INC., a corporation organized under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLEI

The name of this corporation shall be: LIGHTNING STRIKE, INC.

ARTICLE II

Corporate existence shall begin at the time these Articles are filed with the Department of State.

This Corporation shall exist perpetually, unless sooner dissolved according to law.

ARTICLE III
