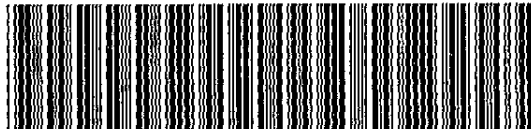

OF

The undersigned for the purpose of organizing a Florida Profit Corporation adopt the following Articles of Incorporation:

1. The name of the Corporation is JF CATTLE COMPANY, INC. and its principal place of business 7510 NW 258th Avenue Alachua, FL 32615; and the mailing address is: 7510 NW 258th Avenue Alachua, FL 32615.

2. The duration of the Corporation is perpetual.


