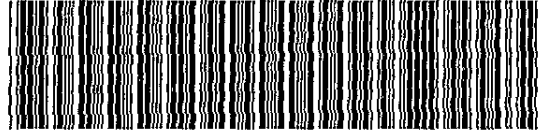

**ARTICLES OF INCORPORATION

I, the undersigned Incorporator, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is:

The Principle place of business of this corporation shall be 3455 Ohio Avenue, Sanford, Florida 32773.

**ARTICLE II**

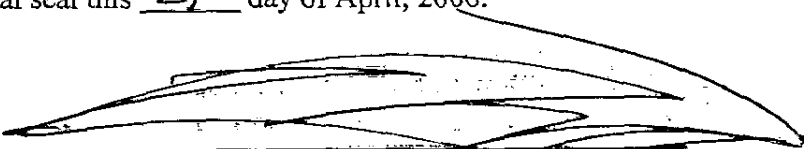

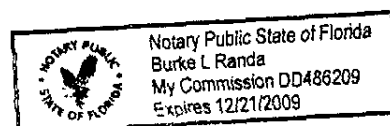

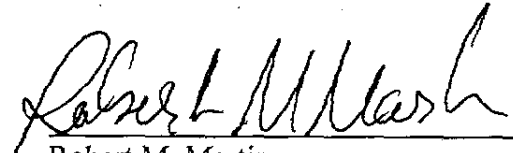
