**ARTICLES OF INCORPORATION

In compliance with the requirements of F.S. Chapter 607, the undersigned hereby act as incorporators in adopting and filing the following articles of incorporation for the purpose of organizing a professional corporation.

**ARTICLE I**

The name of the professional corporation is: **GLARY & SACKS, P.A.**, and the Principal office and mailing address of said corporation is as follows: 1646 Emerson Street, Suite B, Jacksonville, Florida 32207.

**ARTICLE II**

This professional corporation is organized to engage in any activity permitted under the laws of the United States or of this State, and for the specific purpose as a law firm.


## **ARTICLE IX**


