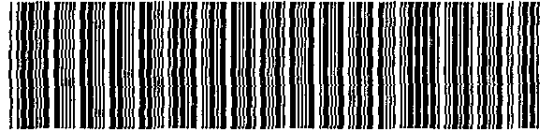

The undersigned subscribers do hereby make and execute these Articles of Incorporation for forming a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation is:

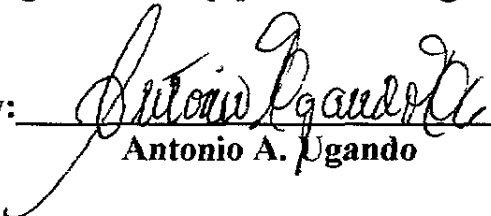
