ARTICLES OF INCORPORATION OF SKIN CARE CENTER OF OCALA, INC.

- 1. The name of this Corporation is SKIN CARE CENTER OF OCALA, INC.
- 2. The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.
- 1. The maximum number of shares of stock that this Corporation is authorized to issue and have outstanding at any one time is 100 shares of common stock, having a par value of \$1.00 per share.
- 3. This Corporation shall have perpetual existence commencing upon filing of these Articles.
