ARTICLE III (CAPITAL STOCK)

The maximum numbers and class of shares of stock that this Corporation is authorized to have outstanding at any one time are: 100 shares no par value.

ARTICLE VI (SHAREHOLDERS)

Shareholders meetings will take place once a year within or without the geographical boundaries of the State of Florida.

A majority of the shares entitled to vote, represented in person or proxy, shall constitute a Quorum, but in no event shall a Quorum consist of less than one third of the shares entitled entitled to vote at the meeting.

Shrareholders willhave the power to adopt, alter, amend or repeal corporate bylaws or they may vest such responsibilities on the Board of Directors.

ARTICLE VII (DIRECTORS)

The Corporation shall have 3 (three) Director initially. The number of directors may be increased or decreased from time to time in such manner as may be prescribed by the By-Laws, but shall never be less than 1 (one).

The Corporation shall indemnify and hold hamless each person who shall serve at any time hereafter as a director or officer of the Corporation, and any person who serves at the request of this Corporation, as a director or officer of any other corpration, from and against any and all claims and liabilities to which such person shall become subject by reason of his having heretofore or hereafter been a director or officer of the Corporation, or by reason of any action alleged to have be hereytofore or hereafter taken or omitted by his as such director of officer, and shall reimburse each such person for all

legal and other expenses reasonably incurred by him in connection with any claim or liability provided that no person shall be indemnified against, or be reimbursed for, any expenses incurred in connection with any claim or liability as to which it shall be adjudged that such officer or director is liable for negligence or will full misconduct in the performance of his duties.

The rights accurring to any person under the foregoing provisions shall not exclude any other right to which he may be lawfully entitled nor shall anything herein contained restrict the right of the Corporation to indemnify reimburse such person in a proper case even though not specifically herein provided for.
