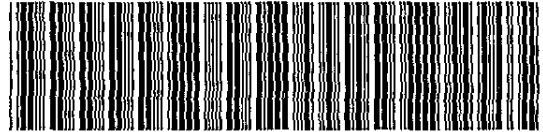

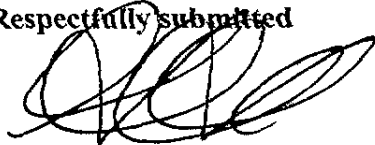

ARTICLES OF INCORPORATION
FOR
DENVAL HOLDING, INC.

The undersigned, acting as incorporators for this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby form a Business Corporation under the laws of the State of Florida and adopt the following Articles of Incorporation for such corporation.

ARTICLE I
NAME OF CORPORATION

The name of the corporation shall be DENVAL HOLDING, INC.

ARTICLE II
TERM OF EXISTENCE

This corporation shall begin its corporate existence as of the 26 day of APRIL, 2006, and shall exist perpetually.

ARTICLE III
GENERAL PURPOSE

The general purpose for which this corporation is organized shall be the conduct of buying and selling mortgages and all things in connection therewith that are related under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.
