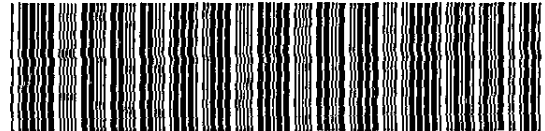

INDEMNIFICATION






