ARTICLE I - NAME

The name of this corporation is **GAR'S CLEANING SERVICE, INC.**

ARTICLE II - DURATION

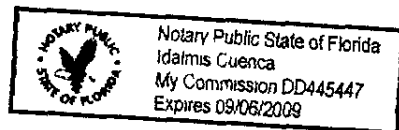
