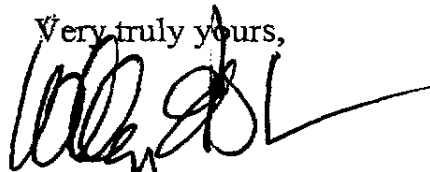

**ARTICLES OF INCORPORATION**  
**OF**

The undersigned, acting as the incorporator of FRENCH MANAGEMENT, INC., a Florida corporation (the "Corporation"), pursuant to Chapter 607 of the Florida Statutes, hereby forms a corporation for profit under the laws of the State of Florida and adopts the following Articles of Incorporation for the Corporation.

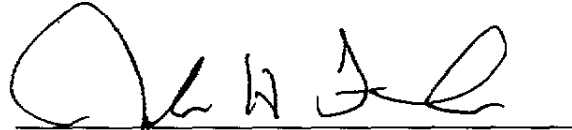
ARTICLE XI - BYLAWS

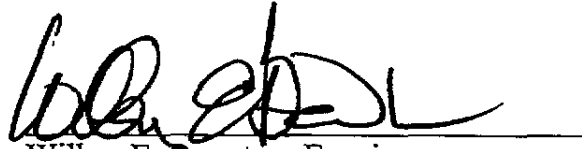
