**ARTICLES OF INCORPORATION
OF
JUNEE F. GARDY, D.D.S., P.A.**

THE UNDERSIGNED, acting as sole incorporator of a corporation to be formed under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

FIRST: The name of the corporation (the "Corporation") is:

JUNEE F. GARDY, D.D.S., P.A.

The purpose for which this corporation is formed is to allow the licensee to conduct all business authorized and lawful for the licensee under Chapter 466 (Dentistry) of the Florida Statutes through this entity.


