**ARTICLES OF INCORPORATION
OF
AMMED HOLDINGS I, INC.**

The undersigned, acting as incorporator of a business corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation for such business corporation.

**ARTICLE I
NAME, ADDRESS AND REGISTERED AGENT**

1.1 **Name.** The name of the corporation shall be AmMed Holdings I, Inc. (the "Corporation").

1.2 **Principal Office and Mailing Address.** The principal office and mailing address of the Corporation shall be 6101 Central Avenue, St. Petersburg, Florida 33170.

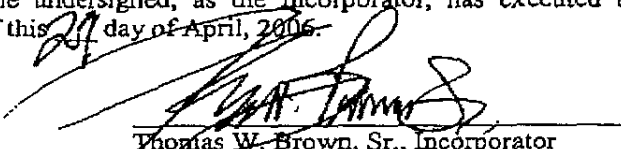
ARTICLE VI

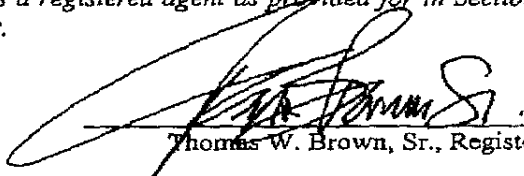
