We, the undersigned, do hereby associate ourselves together and subscribe this Certificate of Incorporation for the purpose of forming a corporation under the laws of the State of Florida, and subject to the following provisions:

## **ARTICLE I**

THE NAME of the Corporation shall be:

#### **ARTICLE II**

THE CORPORATION may engage in any activity or business permitted under the laws of the United States of America and of the State of Florida.

#### **ARTICLE III**

THE MAXIMUM number of shares of stock which the Corporation shall have outstanding at any time, shall be FIVE HUNDRED (500) shares of stock which shall be common stock of a par value of ONE DOLLAR (\$ 1.00) per share.
