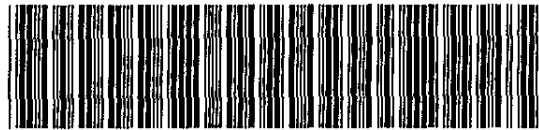

ARTICLES OF INCORPORATION

OF

ARTICLE I

NAME : The name of this Corporation is : S P S TILE AND RENOVATIONS, INC.

ARTICLE II

PRINCIPAL PLACE OF BUSINESS AND MAILING ADDRESS FOR CORPORATION : The street address of the initial principal and registered office of this corporation is 431 Robin Road , Davenport, County of Polk, State of Florida 33896. ARTICLE III

BUSINESS AND ACTIVITIES : This Corporation may and is authorised to ,engage in any activity or business permitted under the laws of the United States Of America and of the State of Florida.

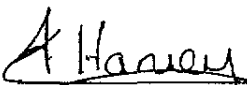
ARTICLE XIV

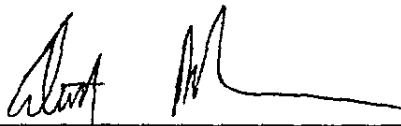
