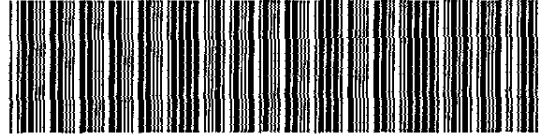

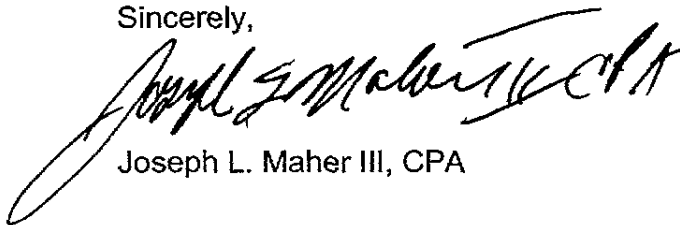

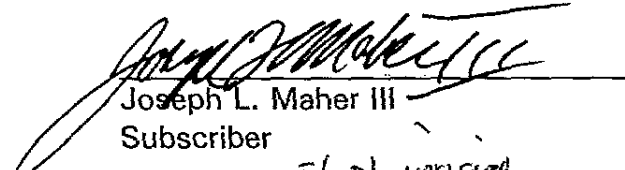
ARTICLE X - IDEMNIFICATION

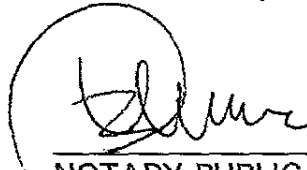

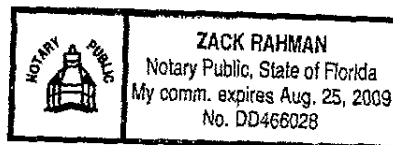

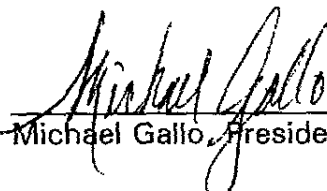
