ARTICLES OF INCORPORATION

OF

TILE GATORS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: **TILE GATORS, INC.**

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be 3410 Lake Padgett Drive, Land O' Lakes, Florida 34639 - 4510.

ARTICLE III: EXISTENCE AND DURATION

This corporation shall exist perpetually commencing on April 28, 2006.

2. To engage in any activity or business permitted under the laws of the United States and of this State, as the same may be from time to time amended.

ARTICLE V: SHARES/CAPITAL STOCK

The aggregate number of authorized shares of stock this corporation is authorized to have outstanding at any one time is 100,000 shares of ONE CENT (\$0.01) par value common stock, which shall be designated "Common Shares". The corporation elects to have preemptive rights.

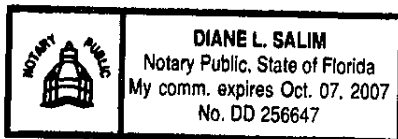


