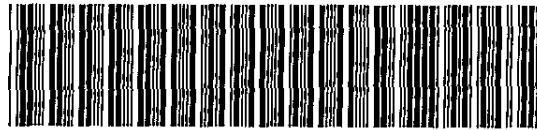



OF

ARTICLE I

The name of this corporation is MILLENIUM PLUS, INC.




