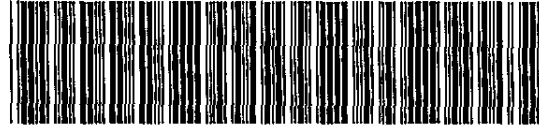

THE UNDERSIGNED SUBSCRIBERS TO THESE ARTICLES OF INCORPORATION EACH A NATURAL PERSON COMPETENT TO CONTRACT HEREBY ASSOCIATE THEMSELVES TOGETHER TO FORM A CORPORATION UNDER THE LAWS OF THE STATE OF FLORIDA AND FURTHER TO AGREE TO THE FOLLOWING CONDITIONS OF SAID COPORATION.

ARTICLE I: NAME

THE NAME OF THE CORPORATION IS

ARTICLE II: PURPOSE

THE CORPORATION IS ORGANIZED FOR THE FOLLOWING PURPOSES: TO MAINTAIN AND OPERATE AN AUTO REPAIR BUSINESS.
