

ARTICLE I

Name and Principal Office

The name of this corporation is DEBORAH TREMBLAY AA AGENT, INC. The principal place of business and mailing address of this corporation is 3423 East Silver Springs Blvd., Suite 3B, Ocala, FL 34470.

ARTICLE II

Duration

This corporation shall have perpetual existence commencing on the date of execution and acknowledgment of these Articles.

ARTICLE III

Purpose

This corporation is organized for the purpose of transacting any and all lawful business, except that this corporation is not authorized to engage in the business of banking, insurance or engineering.

ARTICLE IV

Capital Stock
