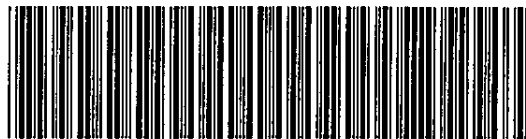

ARTICLES OF AMENDMENT FOR NAME CHANGE

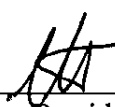

2. The foregoing amendment was adopted by the sole Stockholder and sole Director of the corporation on the 21st day of December, 2006.

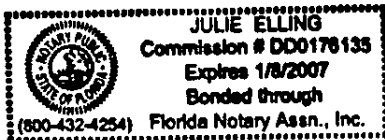
