ARTICLES OF INCORPORATION

OF

S & S SCREENS AND MORE, INC.

The undersigned hereby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I - Name

The name of the corporation is S & S SCREENS AND MORE, INC.

ARTICLE II - Principal Office and Mailing Address of the Corporation
