

The name of the corporation is, DAN HATCH, INC.

II. TERM OF EXISTENCE

IX. SUBSCRIBER AND INCORPORATOR



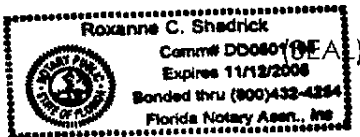
stockholders and all the directors sign a written statement manifesting their intentions that a certain amendment of these Articles of Incorporation be made


