We, JOHN L. DIETRICH, D.D.S. and THOEDORA K. KALONAROS-DIETRICH, D.D.S., the undersigned, who are both licensed to practice dentistry in the State of Florida, adopt these articles to form a corporation under the Professional Service Corporation Act, F.S. Chapter 621, in accordance with the laws of the State of Florida.

ARTICLE I - NAME

The name of this corporation shall be:

DIETRICH DENTAL SERVICES, P.A.

ARTICLE II - PURPOSE

This professional service corporation is organized to engage in every phase and aspect of the practice of dentistry. In addition, the professional service corporation may invest the funds of the professional service corporation in real estate, mortgages, stocks, bonds or any other type of investment, and own real and personal property necessary for the rendering of professional services.

ARTICLE III - CAPITAL STOCK

A. The total number of shares of capital stock which the corporation shall be authorized to issue is 10,000 shares. Such shares shall be of a single class of common stock and shall have a par value of \$1.00 per share.

B. Each shareholder must be duly licensed or otherwise legally authorized to practice dentistry in the State of Florida.

C. No shareholder shall enter into a voting trust agreement or any other type agreement vesting another person with the authority to exercise the voting power of any or all of his stock.

ARTICLE IV - DURATION

This corporation shall have perpetual existence commencing upon filing of these Articles.

Any director of this corporation who is also a director or officer of such other corporation or member of such firm or who is interested may be counted in determining the existence of a quorum at any meeting of the board of directors of this corporation which shall authorize any such contract or transaction, with like force and effect, as if he were not such officer or director of such other corporation or member of such firm, or not so interested.
