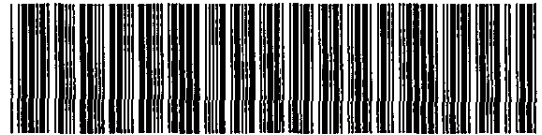

ARTICLE I

NAME:

The corporation is organized to engage in any and all business permitted under the laws of the State of Florida.

CAPITAL STOCK:


**ARTICLE IX


