ARTICLE I - NAME

This corporation is to exist perpetually.

ARTICLE III - PURPOSE

This corporation may engage or transact in any or all lawful activities or business permitted under the Laws of the United States, the State of Florida, or any other state, country, territory, or nation.

This corporation is authorized to issue Five Hundred (500) shares of One (\$1.00) par value common stock.
