OS MAY S AM II: 11 The undersigned, for the purposes of forming a corporation under Section 607.0202 of the Florida Business Corporation Act, does hereby certify as follows:

ARTICLEI

Corporate Name and Address

The name of the Corporation is SONA Enterprises, Inc., and the street address of the Corporation is 3570 Bayshore Drive, #C-2, Naples, Florida 34112.

ARTICLE II

Corporate Purposes

The Corporation is organized to transact any and all lawful business authorized by the Florida Business Corporation Act.
