ARTICLES OF INCORPORATION OF

ARTICLE I
CORPORATE NAME

The name of the corporation is DOCENT, INC.

ARTICLE II
DURATION

This corporation shall be perpetual existence commencing on the date of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III
PURPOSE

This corporation is organized for the purpose of transacting any or all lawful business.

CAPITAL STOCK

This corporation is authorized to issue Seven Thousand Five Hundred (7,500) shares of one dollar (\$1.00) per value common stock, which shall be designated "common shares".

AMENDMENTS TO BY-LAWS

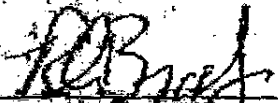
The power to adopt, alter, amend or repeal By-Laws shall be vested in the Board of Directors.

This corporation shall have all of the corporate powers enumerated in the Florida General Corporation Act.

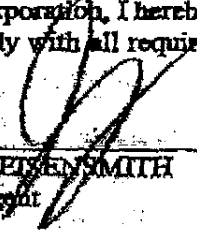
ARTICLE XIII

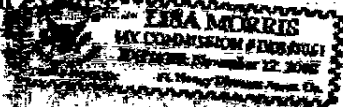

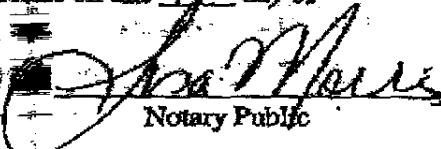
