

ARTICLES OF INCORPORATION

OF

JOEY MAC MANAGEMENT, INC.

The undersigned, for the purpose of forming a Corporation under the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I. - CORPORATE NAME

The name of the Corporation is JOEY MAC MANAGEMENT, INC.

ARTICLE IL - CORPORATE DURATION

The duration of the Corporation is perpetual, and the Corporate existence is to commence upon the execution hereof.

<u>ARTICLE III. - PURPOSE AND POWERS</u>
