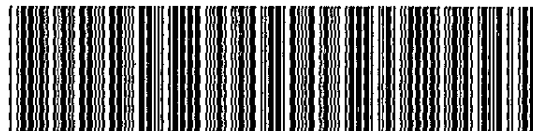

Articles of Incorporation

The undersigned, who is duly licensed to practice law in the State of Florida, desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following Articles of Incorporation:

Article 1

The name of the professional corporation is Tanner Andrews, P.A.

Article 2

The purpose for which the corporation is organized is to practice the profession of law.

Article 3

The term of existence of the corporation is perpetual.

Article 4

The Corporation elects to be governed by the provisions of the Florida Professional Service Corporation and Limited Liability Company Act.

Article 5

The number of shares the corporation is authorized to issue is 1000, all of which shall be common shares with par value of \$1.00 per share.

Article 6

The amount of capital with which the corporation shall begin business is \$1000.00.

Article 7

The street address of the Corporation's initial registered office in this State is 107 E. Church St., DeLand, FLA 32724. The initial registered agent at the registered office is Astrid de Parry, P.A.

Article 8
