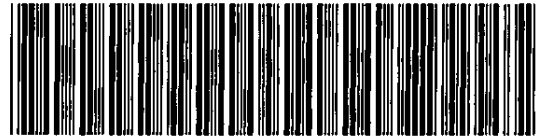



In compliance with the requirements of Chapter 607 of the Florida Statutes, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I

The name of the Corporation ("Corporation") is PHYSICIAN PROFESSIONAL SERVICES, P.A.

ARTICLE II

The existence of the Corporation shall begin immediately. The purpose of the corporation is to provide health care providers with auditing or consulting services regarding propriety of billing and payment for health care services and to provide insurance companies with trends in billing fraud or abuse.

ARTICLE III

The street and mailing address of the principal office of the Corporation is 146 Hidden Cove Drive in Melbourne Beach, Florida 32951.

ARTICLE IV

The maximum number of shares this Corporation is authorized to issue is 100, par value \$.01 per share, all of which shall be Common Shares. 


