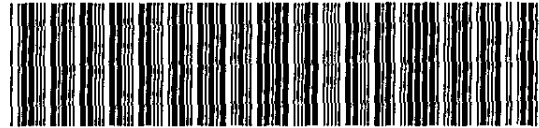

The undersigned subscribers to these Articles of natural persons competent to contract, hereby form a Corporation under the laws of the State of Florida.

**ARTICLE I - NAME**

The name of this Corporation is MARK CHAMBERLAIN, INC.

**ARTICLE II - DURATION**

This Corporation shall exist in perpetuity, commencing five (5) business days prior to the time of filing these Articles with the Department of State, unless dissolved according to Florida Law.

**ARTICLE III - CAPITAL STOCK**

This Corporation is authorized to issue five hundred (500) shares of capital stock, which shall be designated Common Stock. All common shares shall be identical with each other in every respect, and the holders thereof shall be entitled to one (1) vote for each share upon matters on which shareholders have a right to vote.

**ARTICLE IV - PRINCIPAL OFFICE**

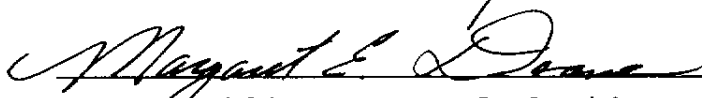

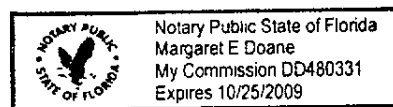
