The undersigned, desiring to organize a Professional Service Corporation for the purpose hereinafter stated, pursuant to the laws of the State of Florida, hereby certifies as follows:

ARTICLE I

Name

The name of the corporation is **FATIMA A. FINAMORE, P.A.** and its principal business address is: 5058 Greenwich Preserve Court, Boynton Beach, Florida 33436.

ARTICLE II

Duration

This corporation shall have perpetual existence.

ARTICLE III

Purpose

The general nature of the business to be transacted by the corporation shall be to engage in the practice of real estate sales. The professional services involved in the corporation's practice of real estate may be rendered only through its officers, agents and employees who are duly authorized and licensed to practice in the State of Florida.

Bylaws


