ARTICLE 1

NAME

The name of this Professional Corporation is JOHN M. WYNN, P.A. and is being organized pursuant to Chapter 621 of the Florida Statutes.

ARTICLE 2

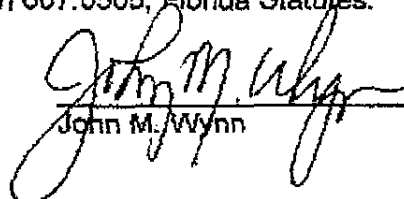
