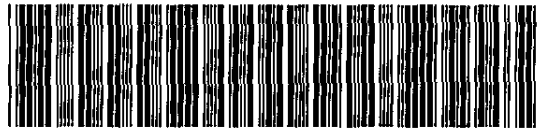

In compliance with the requirements of F.S. Chapters 607 and 621, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I**

The name of the Corporation ("Corporation") is AUREL CIOBANU, D.M.D., P.A.

**ARTICLE II**

The existence of the Corporation shall begin upon filing.

**ARTICLE III**

The purpose of the Corporation shall be to practice the profession of general dentistry. The Corporation may engage in the transaction of any and all aspects of the practice of dentistry.

**ARTICLE IV**

The street address of the principal office of the Corporation is 888 Brickell Key Drive, #2300, Miami, FL 33131.

**ARTICLE V**

The maximum number of shares this Corporation is authorized to issue is 1,000, par value \$.01 per share, all of which shall be Common Shares.
