

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

#### ARTICLE I NAME

The name of the corporation shall be: Wideopen Trucking, Inc.

#### ARTICLE II PRINCIPLE OFFICE

The mailing address of the initial office of this corporation is 12797 NE 210<sup>th</sup> Street Road, Ft. McCoy, Florida 32134. The Board of Directors may, from time to time, change the street and post office address of the principal office of the corporation.

#### ARTICLE III PURPOSE

To engage in any activity or business permitted under the laws of the United States and the State of Florida.

#### ARTICLE IV CAPITAL STOCK

This corporation is authorized to issue 100 shares of common stock.

Any conflict between the provisions hereof and thereof shall be controlled by the provisions of the Shareholder Agreement.

#### ARTICLE V TERM OF EXISTENCE

This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Secretary of State of the State of Florida.

#### ARTICLE VI INITIAL REGISTERED AGENT AND ADDRESS
