# STATE OF FLORIDA ARTICLES OF INCORPORATION OF TC Global Tech, Inc.

The undersigned, for the purpose of forming a Corporation under the Florida General Corporation Act, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I Name

The name of the Corporation is TC Global Tech, Inc.

ARTICLE II Principal Place of Business

The principal place of business is 4736 Jetty Street, Orlando, FL. 32817.

ARTICLE III
Purpose

The Corporation may transact any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.
