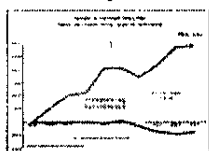
I look forward to hearing from you soon, as more than the required time has been given and I am trying to help you to avoid the **\$400.00 non-negotiable** late fee.
