# ARTICLES OF INCORPORATION FOR AMERICAN IMPACT MANAGEMENT CORP.

SECRETARY OF STATE TALLAHASSEE, FLORIDA

THE UNDERSIGNED hereby makes, subscribes, acknowledges and files with the Secretary of the State of Florida, these Articles of Incorporation for the purpose of forming a Corporation for profit, in accordance with the laws of the State of Florida.

# ARTICLE I

#### Name

The name of the Corporation shall be AMERICAN IMPACT MANAGEMENT CORP.

# ARTICLE II

# Address

The initial street address of the principal office of this Corporation shall be, 6271 N. W. 110th Terrace, Hialeah, Florida 33012.

#### ARTICLE III

#### Existence

This Corporation shall have a perpetual existence.

# ARTICLE IV

#### Purpose

This Corporation is organized for the purpose of transacting any lawful business in the United States, and shall have all powers relating thereto, and to engage in and transact any lawful business for which corporations may be incorporated under the laws of the State of Florida.

#### ARTICLE V

#### Capital Stock

The Corporation shall have the power to purchase and maintain insurance on behalf of any person who is or was a Director or Officer of the Corporation against any liability asserted against him/her and incurred by bim/her in any such capacity, or arising out of his/her status as such, whether or not the Corporation has the power to indemnify him/her against such liability under the provision of this section.
