ARTICLES OF INCORPORATION FILED OF TALLAHASSEE CARDIOLOGY ASSOCIATES, P.A. 11 2 11: 14:3

The undersigned, being duly licensed to practice medicine in the State of Florida and desiring to form a professional corporation in accordance with Chapter 621, Florida Statutes, hereby adopts the following Articles of Incorporation:

I. NAME AND PRINCIPAL PLACE OF BUSINESS

The name of the corporation is TALLAHASSEE CARDIOLOGY ASSOCIATES, P.A. The corporation's initial place of business shall be 2617 Mitcham Drive, Suite 102, Tallahassee, Florida 32308.

II. REGISTERED OFFICE

The address of the corporation's initial registered office in this state is Joseph Baker, M.D. The initial registered agent at the registered office is 2617 Mitcham Drive, Suite 102, Tallahassee, Florida 32308.

III. PURPOSE

The purpose for which the corporation is organized shall be to engage in and engage in the practice of medicine in the State of Florida, and for all other lawful purposes related thereto.

IV. DURATION

The term of existence of the corporation shall be perpetual.

V. PROFESSIONAL SERVICES

The professional services of the corporation shall be rendered only through its officers, employees and contract service providers who are duly licensed or otherwise legally authorized to practice as physicians and licensed medical professionals within the State of Florida.

VI. INCORPORATORS

The name and address of the incorporator is Joseph Baker, M.D., whose address is 2617 Mitcham Drive, Suite 102, Tallahassee, Florida 32308.

VII. SHARE STRUCTURE

7.1 Classes of Shares.

The maximum number of shares that the corporation is authorized to have outstanding shall be ten thousand (10,000) shares of voting capital common stock, having a par value of ten cents (\$0.10) each.

7.2 Restrictions on Issuance and Transfer.

No share of any of the capital common stock of this corporation shall be issued or transferred to any person who is not a physician duly licensed to practice medicine in the State of Florida. Nothing herein shall prevent the corporation and its shareholders from entering into any written agreement(s) further restricting or providing terms for the transfer of the stock of the corporation.

7.3 Preemptive Rights: Cumulative Voting.

Holders of the capital stock of the corporation shall have the preemptive right to purchase new shares of stock or securities, and shall also have the preemptive right to acquire stock or securities of the corporation. Cumulative voting shall not be allowed in the election of directors or for any other purpose.

VIII. AMENDMENT OF ARTICLES

The corporation may, at any time, and from time to time, amend these Articles of Incorporation in the manner now or hereafter permitted by statute. Any change authorized by the holders of shares entitling them to exercise a majority of the voting power of the corporation (or such greater number as may then be required by statue) shall be binding and conclusive on every shareholder of the corporation, as fully as if each shareholder had voted for the change.

IX. INDEMNIFICATION

The corporation shall indemnify each of its officers, directors and employees, whether or not then in office, and his or her heirs and legal representatives against all expenses, judgments, decrees, fines, penalties or other amounts paid in satisfaction of, in settlement of, or in connection with the defense of any pending or threatened civil action, suit or proceeding to which he or she is or may be made a party by reason of having been a director, officer or employee of the corporation, to the extent permitted by applicable law.
