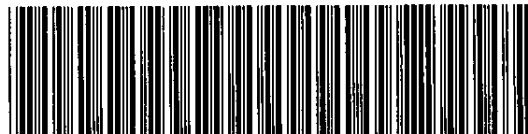

THE UNDERSIGNED duly authorized President of Tallahassee Cardiology Associates, P.A., a Florida professional service corporation (the "Corporation"), hereby makes these Articles of Dissolution for the purpose of dissolving the Corporation in accordance with Chapter 607, Florida Statutes, and states as follows:

1. The name of the Corporation being dissolved is Tallahassee Cardiology Associates, P.A.
2. The document number of the Corporation is P06000066766.
3. The Corporation's dissolution has been authorized and a written plan of dissolution providing for the liquidation of its assets and the payment of its obligations, and these Articles of Dissolution, have been adopted and approved by the unanimous written vote and consent of its directors and shareholders on December 22, 2015, which vote and consent is sufficient to approve the Corporation's dissolution pursuant to Chapter 607.
4. The Corporation is authorized and directed, by and through its President and other appropriate officers, to take all actions and to do all things necessary and appropriate to liquidate and distribute its assets and wind down its business and affairs as authorized by Section 607.1405, Florida Statutes.

6. These Articles of Dissolution shall be effective as of December 31, 2015.
