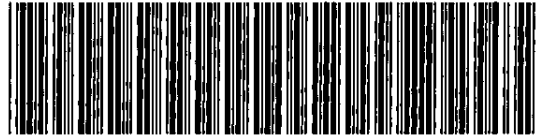



ARTICLES OF INCORPORATION

OF

A PLUS FIRE AND SECURITY, INC.

ARTICLE I- NAME

The name of this corporation is:

A PLUS FIRE AND SECURITY, INC.

ARTICLE II- DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III- PURPOSE

This corporation is organized for the general purpose of engaging in the general business of fire and security systems installations and monitoring, and any other lawful business under the laws of the State of Florida, and to own real and personal property necessary for the rendering of the above services.

ARTICLE IV- CAPITAL STOCK

This corporation is authorized to issue 100 shares of One Dollar (\$1.00) par value common stock which shall be designated as "Common Shares."

ARTICLE V- PRE-EMPTIVE RIGHTS


ARTICLE IX- INDEMNIFICATION




